### AFICC Membership Categories - Fellow, Associate and Student-Faculty

#### Fellow, AFICC

Annual Dues \$450.00

The Fellow designation will be awarded to only those individuals who have demonstrated superior and extensive participation in the forensic field of chiropractic. Once awarded the letters "Fellow, AFICC" can be used on letterhead and to denote professional designation as an AFICC Fellow.

1. Independent disability evaluator certification, QME or equivalent as determined by AFICC board.
2. Submission of most recent permanent and stationary, ratable worker's' compensation report and most recent final personal injury narrative report.
3. Curriculum vitae and other verifications as requested by credentials committee chairman.
4. Agreement to attend one AFICC sponsored seminar per year.
5. Candidates must have no physical or mental impairments that would preclude them from participating as a consultant, and must be able to demonstrate good standing with their Board of Chiropractic Examiners.
6. Letter of personal recommendation from AFICC Fellow in good standing.  
This does not preclude the handicapped from membership.

#### The Associate Category

Annual Dues \$150.00

is available for those professionals PhD, MD, JD, MPH, MA, MS, RPT, etc. who have an interest in chiropractic forensics, or those DC's who are not California licensed, but would like to attend AFICC sponsored seminars and be kept current with the AFICC and forensic developments through our newsletters and seminars.
